New Business:

- Deanne was called by Regen during the meeting to announce that half of the proceeds from the Tri-County Area Unity Retreat will be donated to ECCNA 24.
- Theme Ideas- Many ideas were brought to the Host Committee meeting. The four that we decided to vote on were as follows:
 - A ray of light in the darkness
 - Therapeutic value
 - Gratitude into action
 - Living in the moment

The theme "Gratitude into action" received the most votes and will be the theme for FCCNA 2411

- Mike A. brought up concern of the open meeting space in the cafeteria that we had in 2012 and how there wasn't much privacy.
- Kevin R. asked whether or not people can register now for the convention. Mike R. stated that people can go to ECCNA.org and put a deposit down for a full registration.
- The group discussed the topics that the Program committee came up with and stated that all topics look great.
- Mike A. asked when the last meeting of the day will be held so that he can begin planning events for the convention. Kevin R. said that he would get Wayne B's reports from ECCNA 17 for guidance.

Host Chair Report 9-18-2019

Hey gang,

Things are going good and there's a list of things to do so hopefully we are full swing getting this going. We received a message of resignation from James M today so we need to elect a Fundraising and Entertainment person.

I went with Wayne and Amy to Chestertown today to tour the facilities and start a negotiation with the college. I'd like to go over the facilities that are available to us.

The pricing and billing from 2013 is pretty clear, but the obvious chink in it is the way attendants are counted. Wayne is trying to negotiate something that would give us the ability to sell a Saturday only registration with lunch and dinner, and get a reduced rate on a day attendant, lunch dinner combo. Seems like a good tactic. The convention planner at Washington was open to 2 of the suggestions Wayne had, and said she would talk to her boss and get back to Wayne in a few days.

Heres the facility overview. If you get a map to follow along, I can explain what we did last convention (2013) and what I think we could do this convention (2020). The bulk of the convention program was at Gibson Center for the arts. There are 3 meeting rooms there: the Decker Theatre, Tawes Theatre, and Hotchkiss. Next to Gibson is Daly hall. In 2013 we had main meetings and larger workshops in Decker, and workshops in Tawes and Hotchkiss. Merchandise, Jeweler, Taping in a classroom in Daly, but it really was "out of the way". We had a snack store / hospitality in the basement of Casey Academic Center, registration was on the top floor of Casey on Friday, and moved it to Hodson Hall on Saturday. Auction and Bid meeting was in Smith Hall auditorium. Dining is in the Hodson Hall commons on the 2nd floor. We ate there, and had a dance in the egg, also Karaoke there in the TV room. Our apartment housing was in Sassafras or Chester and so was the marathon meetings. Also we had Worcester / Wicomico dormitory housing (bathrooms at the ends of the halls).

This year we wont be forced to have the registration in Casey (thats what happened in 2013) and also we are able to use the "Western Shore apartments" The dorms were remodeled last year. Potentially we can offer 2 packages surrounding different housing, as the dormitory housing could be roughly \$20 cheaper for the weekend, also they are closer but with end hall bathrooms. Im actually, personally, open to staying in the dorms, as its closer: right next to the dining hall. We could have meetings in either of 2 meeting rooms in the Hobson Hall, but we really have much meeting space. I would recommend we have merchandise, jeweler, taping and registartion all in Gibson Center lobby. Its very spacious and complaints in 2013 were that it was out of the way or even hard to find. We could also have the snack vending store there. Shirley promises that we will still be able to smoke and that Washington College will not implement a non smoking campus between now and the convention.

Also we had the auction and bid meeting Saturday pm in the Smith Hall auditorium. This is a meeting space with seating for about 135 and 35 on the balcony. The best thing about this space is that you can eat and drink here. In the Gibson Center meeting space, we can only drink water. Non water is not allowed. Also worth noting that the

convention services person pointed out that Hotchkiss gets really warm in the morning. It has a glass wall that faces the sun in the morning.

Meeting space that is open to us that we did not use are 2 rooms that hold about 100 people or more on the back of Hodson Hall commons. One is in the basement and holds over 100 people and is the presidents room and one is above it. It could be set up for hang out, but also there is the general area of the Hodson, court yards outside, etc.

There's lots of hang out space at Washington College.

One thing I didn't figure out is where we should have the Marathon meeting. We used Sassafrass Hall for our housing in 2013. I believe we need to exit the school buildings so they can get locked up. We used the Sassafras commons for Marathon and hospitality during off hours. Currently we have been talking about using the Western Shore apartments and I don't know if they have a commons space for Marathon or late night hospitality.

Also we took the photo at the stadium in 2013 on Sunday morning. We could do that again, or we could change the time and do it Saturday when more people are present. Also we could change the location, for instance to the Martha Washington Square.

I went to the last AB meeting and we need to get this bank account stright. DeAnne messaged me that she would be missing the meeting, so I will call her tomorrow to get her up to speed and thank you for letting me share.




