- Still nothing new on the IRS issue regarding our request to waiver late fees and interest related to our late filings in the past. We did get another letter from the IRS but it said the same thing as last time we need more time to review
- The new webstore is up and running with payments coming through PayPal. There is option to pay with Venmo which I am not sure we want to keep as we haven't agreed as a Board to use Venmo.
- Most of the rates charged on the webstore are not netting the "charge" amounts the Board agreed to these are some minor differences due to fees. Do we want to discuss adjusting the rates?
- Now that we are using PayPal do we need to purchase new swipe devices? The ones we have are for Square and I don't know if they work with PayPal.
- Nothing new on the status of the Virginia Sales and Use Tax Exemption. I checked the
 website last week and our application is still listed as pending. I did call hoping to speak
 with someone directly but that didn't happen. I left a voice message, and I will call back

again within the next few weeks. The website does say to allow 90 days for processing. We are only about 35 days at this point.
