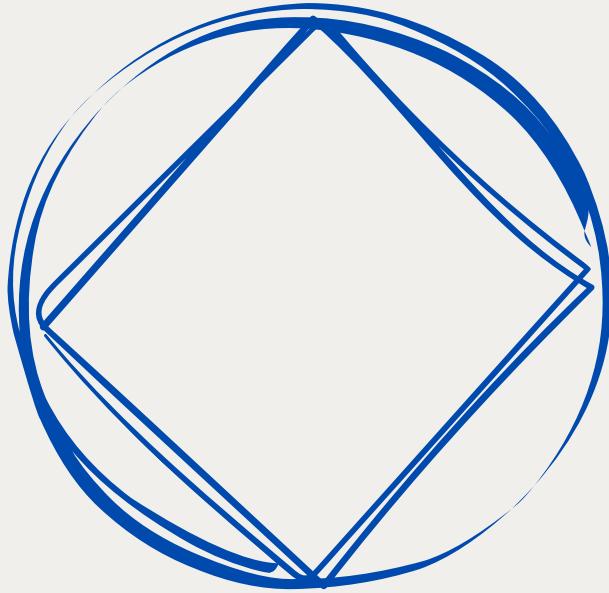

Many moons ago, our father, Bill Humphrey, started Parable Design as a way to offer quality jewelry to those in Narcotics Anonymous. Over the years, he sold jewelry to hundreds of thousands of people like him--seeking a better way to live! He employed and created strategic partnerships with others in recovery.

As children, we traveled with "Mr. Bill" and met so many amazing people who became our extended family. The business became a "family" business which meant that he often relied on his wife, sponsees, friends and children to make everything run.

As a company, we have partnered with the World Service Office of Narcotics Anonymous to provide our products at many World Conventions. Since 1985, our jewelry has been sold at over 1,000 conventions at the area, regional, and world levels--reaching hundreds of thousands of satisfied customers.

In September 2013, Mr. Bill retired after 28 years of traveling to upwards of 50 conventions a year. We remain dedicated to carrying his legacy of offering quality products at competitive prices.

ABOUT US

Parable Design offers gold and sterling silver jewelry and recovery-based gift items such as key tags, medallions, bumper stickers, pins, garments, etc. Since 1985, Parable Design has been the premier jewelry vendor for NA and has been “a part of” over 1,000 conventions at the area, regional and world levels.

PRODUCTS

While many NA vendors are simply resellers, we manufacture our own jewelry using many original molds that our father conceptualized over the years. We create custom work and one-of-a-kind jewelry for conventions often. Parable Design has an on-going product line and is constantly adding new items to respond to trends in the market as well as changes in the fellowship’s phraseology and terminology. We pride ourselves on the craftsmanship of our jewelry and on the creativity of our additional gift items. We aim to provide a wide array of products with price ranges from \$1 to over \$500.

Our jewelry items are manufactured in 10KT gold, 14KT gold and Sterling Silver. The majority of our in-person stock is sterling silver but we also carry 10KT and can custom produce in Sterling Silver, 10KT or 14KT in our shop in Gainesville, FL. We carry items with gemstones such as diamond, topaz, onyx, citrine, aquamarine, ruby, sapphire, etc. Jewelry items include pendants, necklaces, bracelets, rings, charm bracelets, earrings, and custom designed pieces. Jewelry items range in price from \$8 to over \$500. The average price range of gift items is from \$1 to \$10 with many items at a \$3 price point. These items include apparel, medallions, medallion holders, book covers, motto bracelets, pins, bumper stickers, key tags, tote bags, etc.

Our base team is made up of sibling co-owners, Bridgett & Jeff, and our long-standing jewelry finisher, Jim Costa. Our father, Mr. Bill, still acts as a consultant and advisor. Though we have a small team, we have been literally doing this our entire lives. Our children have also grown up much the same way... working NA events and sharing our jewelry with the community.

REGIONAL & AREA CREDENTIALS

We partner extensively with conventions at the regional and area levels throughout the USA. We mostly contract events within the east coast and southern areas but have also worked larger events out west like NCCNA (Northern California). Additionally, Circle of Sisters, CPRCNA (Chesapeake & Potomac), FRCNA (Florida), GRCNA (Georgia) are some of the larger events that have serviced successfully numerous times.

ON-SITE OPERATIONS

PAYMENTS: CASH, CREDIT, DEBIT, CONTACTLESS, & DIGITAL

We accept cash, credit cards & debit cards. Our system processes contactless and card payments as well as transactions with mobile wallets such as Apple, Samsung, and Google Pay. Other methods of payment include: Zelle, CashApp, Venmo, & PayPal.

POST EVENT ORDERS

Custom or additional orders may be placed by phone, internet, or on location at each convention. We post new items and specials frequently through our social media sites and always offer FREE SHIPPING on orders over \$100.

GUARANTEE

Our jewelry comes with a lifetime guarantee. It has always been our policy that if the customer is dissatisfied, we offer a full refund or exchange. We maintain a strong relationship with our customers because the items we manufacture may always be redeemed at full value toward another jewelry purchase.

ON-SITE NEEDS

For on-site sales, we request a secured space (meaning that the space can be locked and accessed by the trusted committee or hotel representative) in a high traffic area. Additionally, we request five - 6 foot tables, three chairs, and one wastebasket.

ON-SITE OPERATIONS

We will service, sell, and maintain our products and area for the duration of your convention. Upon termination of sales, we will pay percentage of sales to your convention.

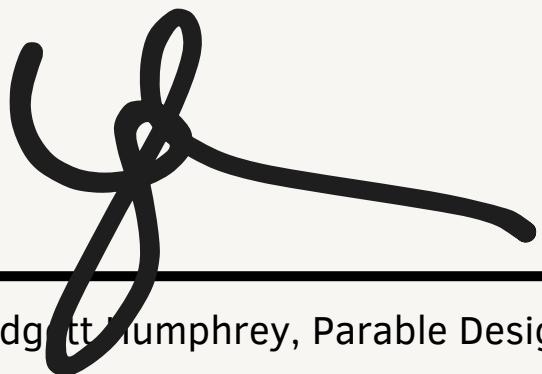

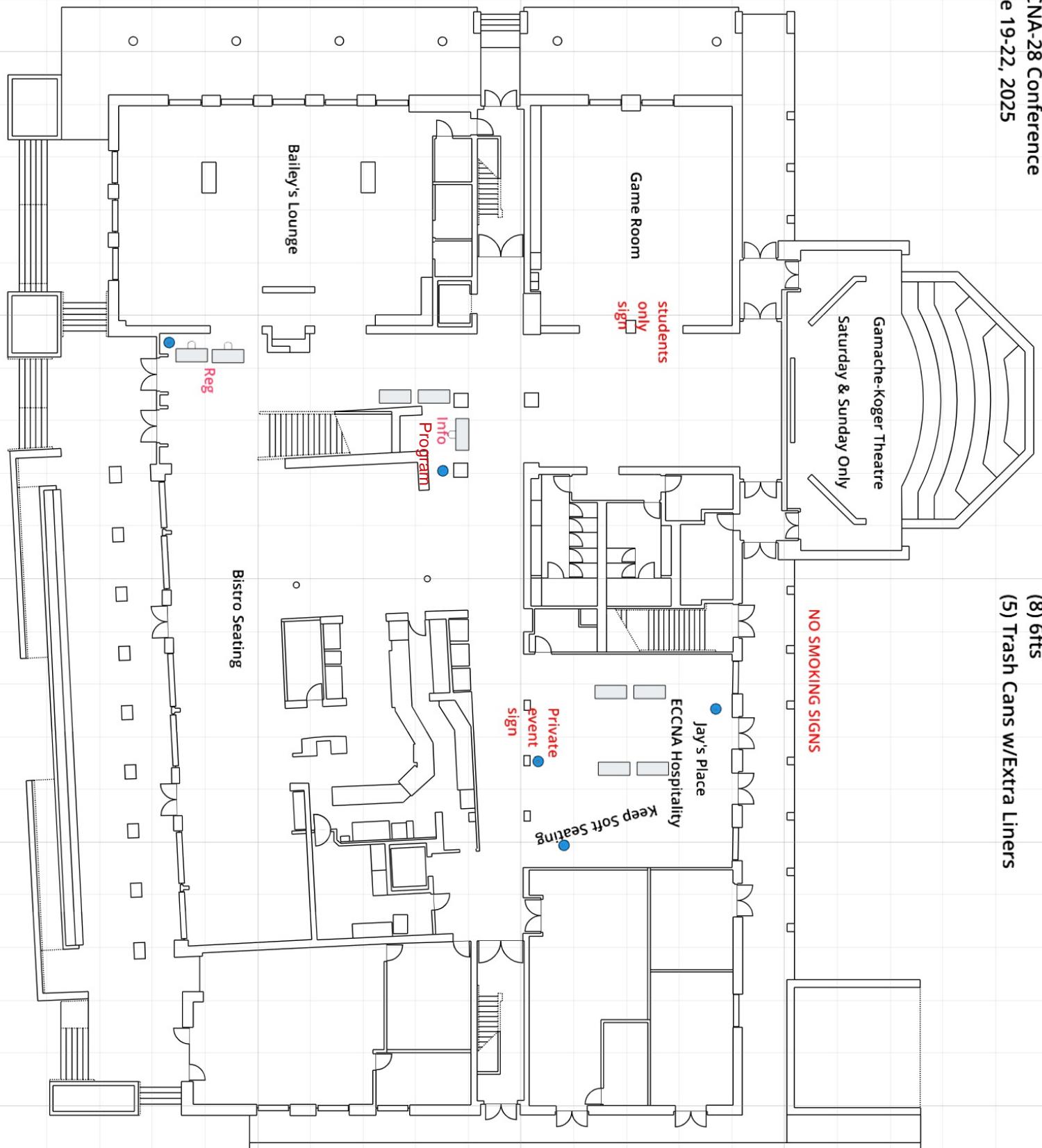

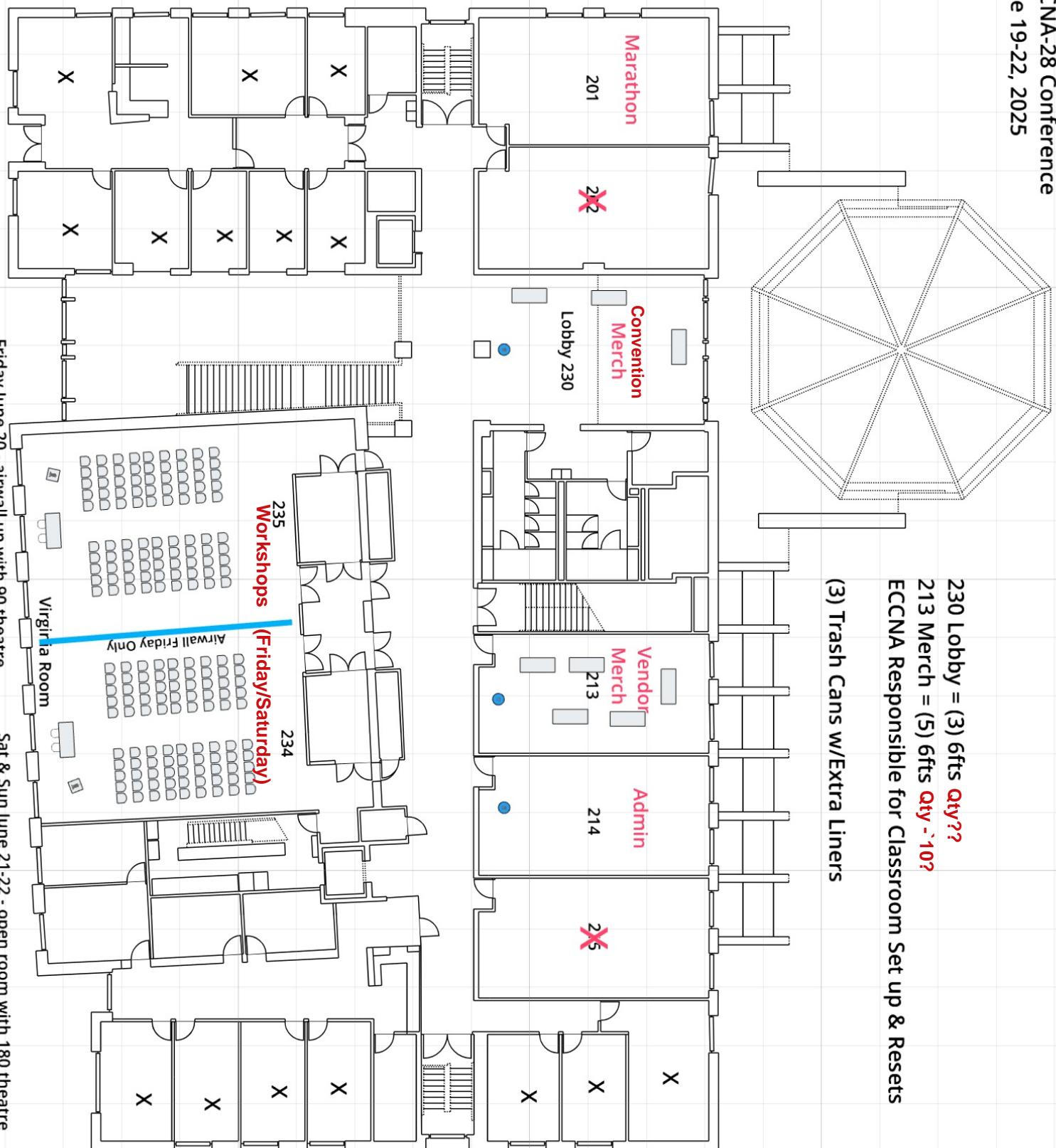
